## OFFICE MEMORANDUM

The Government of Arunachal Pradesh vide Notification No.DA/VI/admn/51//2020 Dated Itanagar the 10<sup>th</sup> February, 2021 had roll out an Electronic Government Receipt Accounting System portal (e-GRAS) i.e., <a href="https://egras.arunachal.gov.in">https://egras.arunachal.gov.in</a> in the State of Arunachal Pradesh being a common collection portal linked with Cyber Treasury under the Directorate of Accounts and Treasuries for realising all Own Tax Revenue, Non – Tax Revenue and Other Receipts of the State Government electronically online.

The pilot run of the e-GRAS portal (<a href="https://egras.arunachal.gov.in">https://egras.arunachal.gov.in</a>) was initiated with the Tax, Excise and Narcotics Department and later on extended to 11 (Eleven) other Departments and Offices.

Considering the successful implementation of the e-GRAS portal by the 12 (Twelve) various Departments and Offices during the period from February 2021 to September 2024, the State Government of Arunachal Pradesh has decided to realise all its Own Tax Revenue, Non – Tax Revenue and Other Receipts electronically online w.e.f. 01.01.2025 REPEAT 01.01.2025 by discontinuing the existing procedure for accepting Government Receipts through Physical Treasury Challan.

All revenue earning Departments under the Government of Arunachal Pradesh are hereby directed to adhere to the above timeline and ensure that they are onboarded on the e-GRAS portal on or before 31.12.2024 REPEAT 31.12.2024 positively.

Government Departments collecting revenues through any other web portal or online system are also directed to integrate their system with the e-GRAS portal on or before 31.12.2024 REPEAT 31.12.2024.

Government Department may either have their portal linked to e-GRAS portal (portal to portal integration) for initiating the collection process at their end by promoting end users facility for filling up necessary forms or directly inform stakeholders / beneficiaries / taxpayers to use the e-GRAS portal.

The Drawing and Disbursing Officers (DDOs) of the Government Departments shall also use the e-GRAS portal for remitting the money collected by them manually in the Agency Bank along with the challan generated from the e-GRAS portal.

All branches of the Agency Bank of Arunachal Pradesh are directed not to accept and tender the Physical Treasury Challans for any Government Receipts w.e.f. 01.01.2025 REPEAT 01.01.2025.

National Informatics Centre (NIC), Itanagar and e-GRAS Project Monitoring Unit (PMU) will provide all required technical support for successful implementation of the e-GRAS in the State of Arunachal Pradesh.

All Departments under Government of Arunachal Pradesh and the Agency Bank of Arunachal Pradesh are hereby directed to comply with necessary integration / support to the e-GRAS technical team for onboarding and integration latest by 31.12.2024 REPEAT 31.12.2024 without fail.

These instructions may kindly be brought to the notice of all concerned of the Government Department for strict compliance.

In the event, the above Government directions are not complied with, necessary action will be initiated against the concerned Government Department as well as Agency Bank of Government of Arunachal Pradesh.
