NOTIFICATION

The Governor of Arunachal Pradesh is pleased to roll out e-GRAS (Government Receipt Accounting System) which will serve the common collection portal for the State of Arunachal Pradesh and would be linked with Cyber Treasury under Directorate of Accounts & Treasuries, Govt. of Arunachal Pradesh for receiving payments electronically.

The NIC Arunachal Pradesh Chapter, Itanagar, may be entrusted as Nodal Agency for on-board, to replicate GRAS Applications of NIC Pune, with customization of NIC, Assam, as per recruitment.

It has been decided that Tax and Excise Department will be on-boarded from 26.01.2021 on test run and will have to mandatorily make all collection using e-GRAS portal only. The same will be rolled out to other revenue Department on a phased manner facilitating collections and formal launch will be done subsequently.

E-Challan approved by PMU may obtain approval from the Finance Department. Payment e-Gateway with SBI to explore. The Project Monitoring Unit (PMU) Nodal Officer shall tie up IT Department for technical and logistic supports.


Creation of Sub-Heads and detailed Heads under 0093 and 0040 to complete by the Finance Department.

The Directorate of Accounts & Treasuries, Govt. of Arunachal Pradesh, Itanagar, may be entrusted the System Administrator of Cyber/Virtual Treasury for the state of Arunachal Pradesh.

The Treasury Officer, Itanagar, may be entrusted as Cyber /Virtual Treasury Officer of the State of Arunachal Pradesh, on ad-interim basis who shall be responsible for approval, reconciliation and submission of Accounts to the Accountant General and shall monitor all function of GRAS.

System Administrator i.e the Director of Accounts & Treasuries, Govt. of Arunachal Pradesh, Itanagar, will be responsible for making necessary system level administrative charges upon request received from concerned Department.


